## Detailed Explanation of Part VI-B – Schedule A

**In fiscal year 7/1/05 – 6/30/06** Centro Sin Fronteras spent \$6,630 in further support of the lobbying activity of immigrant families who were attempting to educate both elected representatives and the general public of the hardships faced by immigrants in the United States, specifically those people with family members residing in the United States and another country.

Once again, this support was manifested in spending \$6,630 to help provide transportation to Washington D.C. for the lobbying activity of the aforementioned immigrant families.

As in the past, at no time was Centro Sin Fronteras itself actively engaged in direct lobbying of elected officials regarding either the overall issue of immigration or any particular legislation affecting the issue of immigration or immigrant families themselves.

Centro Sin Fronteras continues to offer this assistance because of our long-standing relationship with many of the immigrant families involved in this effort.
