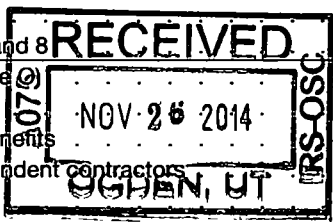

Program Information:

Medical Reserve Corps/ Youth Health Service Corps program: Centro received three grants from the National Association of City and County Health Organizations. A grant for 20,000 was to develop an intensive curriculum and guide to action for developing partnerships with medical and nursing schools, train students in screening for five chronic diseases, related diet and exercise standards and for preparedness for emergency and disasters. 10,000 was paid a consultant to assist in the project which was completed, including an "ap" that can access all parts of the curriculum and guide to action. A grant from NACCHO was also given centro to expand the youth health service corps to six elementary schools. A third grant for 3500 was given for general operating costs of the medical reserve corps unit.

-A summer youth employment program was operated under the direction of the alternative schools network to train 60 high school aged youth in the curriculum and protocols of the youth health service corp and to deploy them in door to door canvassing and a series of health fairs.

-We received a grant of 26,000 from GLOBAL STRATEGIES to identify victims of fraud or financial misrepresentation. We hired a consultant to assist this effort in Waukegan and successfully identified some fifty alleged victims of fraud or financial misrepresentation and assisted them in filing claims with the Illinois Attorney General.

-Centro received a grant of 9,000 from the Hispanic Federation to provide travel and living accommodations at a national Hispanic Educational conference in New York City.

Centro provided training to over 50 pastors and church leaders on the DACA program for "dreamers" and assisted over 400 dreamers in filing their applications. The Centro legal program provided information and referral on immigration matters to over 300 people.

Centro operated after school programs at three high schools and 2 elementary schools related to the youth health service corps program through a community Development Block Grant from the City of Chicago in the amount of 32,881.21
