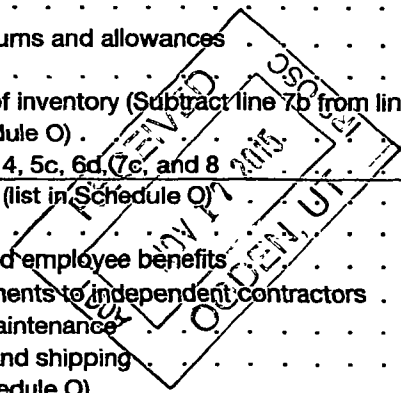

Centro Sin Fronteras Community Services Network sponsors the Familia Latina Unida Medical Reserve Corp. Through this work medical students and staff from FEMA to provide instruction to high school students in emergency preparedness and early detection of diseases such as diabetes, hypertension and heart disease, breast and prostate cancer, asthma and hiv/aids. The students then bring their families and neighbors to health screenings and assist them in accessing insurance and follow-up testing and treatment where indicated. Centro recieved a grant of 3500 from NACCHO to extend this program to the elementary schools.

Centro conducted a series of public hearings on alledged fraud schemes that effect the Latino community and assisted fraud victims in filing complaints with the attorney general of Illinois. Centro recieved support in the amount of 7,000 for this work and spent 10,000 on this project for travel and public hearing expenses.

Although Centro operated solely through volunteers during this period Centro paid \$1654 in previously incurred payroll taxes to the Illinois department of revenue and \$915 to the IRS.
